Fire Prevention By Federated Insurance Company

Applying the COPE characteristics as you look at your facilities can be useful for developing fire-prevention plans. You likely are not able to alter your building's construction, but you can ensure maintenance of heating and electrical systems, and handling of flammable materials. Good housekeeping can eliminate conditions that have the potential to turn into catastrophes. 
